

PARENT/LEGAL GUARDIAN ASSUMPTION OF RISK, WAIVER AND RELEASE
PLEASE COMPLETE THIS FORM FOR A TEENAGE TO CHECK THEMSELVES IN/OUT

I (we) am/are the parent(s) or legal guardian(s) (singularly or collectively referred to herein as "Parent") of _____, ("Child") and Parent requests the Child be allowed to participate in the Metropolitan Park District of Tacoma's ("Metro Parks") sponsored day camp and related recreational activities [Zoo Explorers Summer Camp] (collectively the "Activity"). Parent further requests the Child be allowed to sign themselves in when arriving for the Activity and sign themselves out when leaving the Activity, all without the necessity of Parent's presence, signature or separate notice being required.



It is important to Parent that the Child is allowed to participate in the Activity and to facilitate that participation that the Child also be allowed to check in to the Activity and check out from the Activity at any time and without Parent being present or provided notice. Parent believes the Child is of suitable age and maturity to allow the Child to self check in and check out. Parent understands there are special dangers and risks inherent not only in allowing Child to participate in the Activity but also to perform self check in and check out without the presence of Parent or notice being required. Those risks include, but are not limited to, the risk of serious physical injury, death or other harmful consequences which may arise directly or indirectly from the Child's participation in the Activity and/or the Child performing a self check in and check out without Parent's knowledge. Being fully informed as to these risks and in consideration of Metro Parks allowing Child to participate in this Activity, Parent, on behalf of himself/herself/ourselves and on behalf of the Child, assumes all risk of injury, damage and harm to the Child which may arise from the Child's participation in the Activity and/or allowing Child to self check in and check out without requiring Parent's presence or knowledge. Parent further agrees, individually and on behalf of the Child, to release, indemnify and hold harmless Metro Parks, its officials, employees, volunteers and agents and agrees to waive any right of recovery that Parent may have to bring a claim or lawsuit for damages against Metro Parks for any personal injury, death or other harmful consequences occurring to the Child or Parent arising out of the Child's participation in the Activity and/or allowing the Child to self check in and check out without Parent's knowledge or notice to Parent

Parent further authorizes any necessary emergency medical treatment that might be required for Child in the event of physical injury and/or accident to Child while participating in the Activity.
